### WILLIAMSBURG NATIONAL GOLF CLUB MEMBERSHIP AGREEMENT

This Agreement is made and entered into between the Williamsburg National Golf Club, hereinafter referred to as the "Club", and \_\_\_\_\_\_, hereinafter referred to as "Member." In consideration of the mutual covenants contained herein, it is hereby agreed by and between each of the parties hereto as follows:

1. Once this Agreement is completed, each Member agrees to be bound by the terms of this Agreement and all Club rules and regulations now in existence or as amended or established by the Club hereafter.

2. Initiation Fees are non-refundable and all monthly dues are to be paid upon receipt of the monthly statement. Monthly dues start on the first of the month following the date this Agreement is signed and are posted on the first day of each month thereafter.

3. The Club may, at times, offer special rates for annual memberships. The Club reserves the right, and has sole discretion, to increase, decrease, change or modify the annual membership fee, including but not limited to, any initiation fee, cart fee, locker fee, range fee and monthly dues.

4. Member hereby agrees, as of the date of this agreement to remain a Member and pay the monthly dues for the period agreed upon above.

5. Member shall be entitled to enjoy all privileges of use of the clubhouse and golf course subject to the restrictions contained in this Agreement and Club Rules and Regulations

6. The Member shall be in default of the Agreement if any of the following shall occur: The Member fails to pay monthly dues to the Club or pay when due any other fees, charges, or other payments required by the Club. The Member violates any of the Club Rules & Regulations, codes of conduct or dress code.

7. In the event of default of this agreement by the Member, the Club shall have the option to either suspend or revoke the Member's membership and all rights and privileges of the Club with no refund of any amount previously paid by the Member. The club also retains the right to pursue any additional remedy available in law or equity. The Member hereby agrees that no form of notice of default shall be required if the nature of the default relates to failure of to pay monthly dues, fees, charges, or any violation of the Club Rules and Regulations. Member also agrees to pay all reasonable attorney fees, investigator fees, and costs in the event this account is turned over for collection.

8. The Club reserves the right to host special events and golf tournaments. Such events may restrict the availability of golf course starting times and any or all Club facilities, including but not limited to, use of the clubhouse, practice range and the golf course itself. The Club shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions, or any and all matters beyond control of the Club.

9. The Member's rights, privileges, or interest under this Agreement are non- transferable.

10. The Member acknowledges the Bylaws and Rules and Regulations provide the details of the Club's membership policies, conduct and Member obligations (posted online www.wngc.com/join).
